JUNIOR FIREFIGHTER APPLICANT – Age 16 or 17

The Fire Company endorses the continuing education of all members. In this regard, Junior Firefighters must maintain a minimum academic average of “C” or its equivalent, or a higher average established by their parents or legal guardian. Each Junior Firefighter may attend a New Jersey State certified fire training academy and successfully complete the New Jersey Firefighter I training curriculum.

Junior Firefighters may only respond to calls between the hours of 6:00 AM and 10:00 PM; under no circumstances may Junior Firefighters leave school to respond to a call, this rule remains in effect during the entire academic year regardless of the individual schedule of the student, i.e. at lunch, free periods, early dismissal, etc.

Junior Firefighters must vacate the fire station by 10:00 PM on any night preceding a scheduled school day, and by 11:00 PM on all other nights.
